



Study Sparkz Student Enrollment Agreement

GRE 5 Week Course

By submitting payment for this course, you agree to the terms and conditions of this and, this constitutes a binding agreement between Study Sparkz and the enrolled student.

1. REGISTRATION

- A. I certify that I am enrolling in the Study Sparkz GRE Course (hereinafter referred to as “The Course”) to increase my GRE score and not for any other purpose.
- B. I certify that I am not an employee or agent of any other test preparation company.
- C. I agree to pay Study Sparkz the full tuition amount.
- D. I understand that I am enrolling in The Course specified above in preparation for a GRE examination that occurs within 45 days after the final class of The Course in which I am enrolled. Failure to take the examination within this timeframe will void guarantee.
- E. I understand that I may enroll in The Course specified above only if there is class space available at that location.
- F. I understand that to reserve a space in The Course I pay my tuition in full.
- G. I understand that it is my responsibility to verify that Study Sparkz has received my signed student enrollment agreement and that my tuition is paid in full at least 7 days prior to the first class meeting.
- H. I agree that my enrollment in The Course cannot be transferred to any other person or persons in whole or in part.
 - I. I agree that Study Sparkz has the right to withdraw me from The Course at any time if my behavior is deemed to be disruptive to the class. No refund will be given to students who are withdrawn from The Course.

2. STUDY SPARKZ MATERIALS

- A. I understand that the materials that I receive as a student (hereinafter referred to as “Study Sparkz Materials”) include, but are not limited to, a GRE Test Prep Manual, ETS Powerprep Software, and the ETS GRE 10th Edition manual.
- B. I agree that the Study Sparkz Materials that I receive as a student in The Course are confidential and cannot be sold, loaned, rented, given away, distributed, advertised for sale on the internet or through any other medium, or exploited in any manner.
- C. I agree that I will not copy or cause to be copied or reproduced in any manner, electronic or otherwise, any of the Study Sparkz Materials, any notes based on these materials, or any notes based on any Study Sparkz classes that I attend.
- D. I agree that any attempt, through any medium, to sell, loan, rent, give away, distribute, or copy any of the Study Sparkz Materials will constitute a breach of this agreement.
- E. I agree that I will not allow another person or persons to use any of the Study Sparkz Materials, any notes based on the Study Sparkz Materials, or any notes based on any Study Sparkz classes that I attend.

3. NO RECORDING OF STUDY SPARKZ CLASSES

- A. I agree that I will not tape-record, video-record, transmit, photograph, or otherwise reproduce in any manner any of Study Sparkz classes that I attend.
- B. I agree that I will not tape-record, video-record, or photograph any Study Sparkz instructor or student in any Study Sparkz class that I attend.

4. TUTORING AND ADMISSIONS CONSULTING

- A. Upon enrolling in this course, I will also receive 2 hours of one-on-one tutoring in preparation for the GRE Exam. I agree that any additional private tutoring and/or admissions consulting that I request from a Study Sparkz employee, including Study Sparkz instructors and admissions consultants, must be arranged through the Study Sparkz administrative office.

5. STUDENT CONDUCT

- A. I agree that I will not engage in any activity in the classroom that would, by commonsense standards, be disruptive to the class as a whole or inconsiderate to other individual students in the class.
- B. I understand that communicating, texting, browsing the internet, or playing games via a cell phone or any other electronic device during class will be considered a breach of Section 5A of this agreement.
- C. I agree that I will not solicit Study Sparkz instructors or students for any reason. This includes, but is not limited to, soliciting instructors for private tutoring or admissions consulting, attempting to sell any item to instructors or students, requesting students to fill out surveys, petitions, or other forms, and soliciting a student or instructor for the purpose of starting any kind of test preparation business.
- D. I agree that I will not discuss with or suggest to any Study Sparkz instructors or students any act that would violate ETS policies pertaining to the administration of the GRE, including, but not limited to any act that constitutes cheating on the GRE.
- E. I understand that Study Sparkz will notify ETS of any breach of Section 5D of this agreement.

6. GUARANTEE OF PERFORMANCE

- A. I understand that Study Sparkz makes no guarantee, express or implied, regarding the score improvement of any student. However, upon successfully completing the course (attendance at all class and test sessions, completion of all homework and practice tests) and the score on my actual GRE (taken within 5 weeks of the conclusion of The Course) does not improve (compared to my first practice test on file with Study Sparkz) I will be permitted to attend a second Study Sparkz GRE course starting within 90 days of the original course for no additional charge.

7. BREACH OF AGREEMENT

- A. In the event that Study Sparkz determines that any of the covenants listed in this agreement has been breached by me, in addition to all other legal remedies Study Sparkz has against me, I agree that Study Sparkz has the right to drop me from The Course without a refund.

8. INTEGRATION

- A. This Agreement constitutes the final, complete, and exclusive statement of the terms of the agreement between Study Sparkz and me pertaining to the subject matter of this Agreement and supersedes all prior and contemporaneous understandings or agreements of the parties. This Agreement may not be contradicted by evidence of any or contemporaneous statements or agreements. No party has been induced to enter into this Agreement by, nor is any party relying on, any representation, understanding, agreement, commitment or warranty outside those expressly set forth in this Agreement.

9. REFUND POLICY

- A. I understand that I will receive the Study Sparkz Materials only when I have paid my tuition in full and have submitted this signed enrollment agreement to Study Sparkz on the first day of class.
- B. I understand that once I have received the Study Sparkz Materials I am not entitled to any refund of the tuition.
- C. I understand that once I have attended any part of The Course, I am not entitled to any refund of the tuition, regardless of whether or not I have received the Study Sparkz Materials.
- D. I understand that I am entitled to a refund of the tuition only if I submit a written request to withdraw from The Course at least 7 days before the first class meeting. I understand that I am not entitled to any refund of the tuition if I withdraw from The Course once The Course has started or if I withdraw from The Course within 7 days before the first class meeting.

I have read this 2-page agreement in its entirety and I hereby accept all of the above covenants, policies, and stipulations with respect to the Study Sparkz GRE Course as binding and effective from and after the date of my enrollment.
